NOTIFICATION WITHDRAWAL OF RECOGNITION/AFFILIATION

It has been observed with great concern that you (Principal Red Roses Islamic Academy Gulshen Iqbal Jhangi Abbottabad) have been committing the following gross irregularities and also violating the clear directives issued from time to time by The Regulatory Authority i. e. BISE Abbottabad.

1. You have been violating the approved scheme of studies by teaching students of class 8th the syllabus of class 9th.
2. Salaries and criteria of the faculty appointed in your institution is not in accordance with the Government Pay scales and as prescribed by the Board.
3. You have also been found violating the Winter Vacations Notification by Government of Khyber Pakhtunkhwa and BISE Abbottabad by calling upon the students of classes 8th, 9th and 10th respectively in the institution during this extreme cold weather.
4. You have been continuously found instigating all the private schools management across the Province in general and Hazara in particular not to submit data of students for Grade-V Assessment 2017 through different sources i. e. Social media website, Print Media, mobile messages for personal ulterior motives thus creating severe problems for BISE Abbottabad to conduct Grade-V Assessment/SSC & HSSC Examinations timely and smoothly.
5. You have also shown stubbornness by not attending the meetings called upon by BISE Abbottabad regarding orientation of Grade-V Assessment.
6. You have been found criticizing and defaming BISEs of Khyber Pakhtunkhwa by issuing statements to print media thus degrading and devaluing the credibility of BISEs.
7. Furthermore, all these gross irregularities carried out are on record and BISE Abbottabad needs no further inquiry or investigation in this regard.

Therefore, on the basis of above gross irregularities and conduct prejudicial to the interests of education, Board of Intermediate and Secondary Education (BISE) Abbottabad in exercise of powers of Regulatory Authority; as provided under Khyber Pakhtunkhwa Registration and Functioning of Private Education Institution Ordinance 2001 as amended from time to time under Section 10 (2) (iv) of Khyber Pakhtunkhwa Act V of 1990 as amended in 2005; **RECOGNITION/AFFILIATION** granted to **RED ROSES ISLAMIC ACADEMY GULSHEN IQBAL JHANGI ABBOTTABAD** for **SSC LEVEL** having **REGISTRATION NO: AS47** is hereby **WITHDRAWN (DE-AFFILIATED)** for Academic Session 2017 onwards.
