Under Chapter-II Section-4 sub-section (1) Clause (f) four members of the Regulatory Authority will be from private schools and under the provision of section -4(2) the member at sub-section (1) Clause(f) shall be elected for the fix term of three years.

- (c) is declared to be of unsound mind by a court; or
- (d) is adjudged as an undischarged insolvent; or
- (e) is incapable of discharging duties by reason of physical or mental infirmity and has been so declared by a Medical Board; or
- (f) stands disqualified by the order of a court to hold any public office; or
- (g) is dismissed from the service of Pakistan or a body or authority owned or controlled by any government in Pakistan.
