SECONDARY SCHOOL CERTIFICATE (9TH & 10TH) (ANNUAL-I) EXAMINATION, 2026.

It is notified for the general information of all concerned, that the Secondary School Certificate (Annual-I) Examination, 2026 of the Board of Intermediate and Secondary Education Peshawar will commence on **31st March, 2026**. Under the Cluster Based Examination System.

INSTRUCTIONS:

- As the admission process is paperless, no hard copies are required to be submitted at BISE Peshawar. However, institutions are directed to retain the admission forms and produce them to SSC Examination Section in case of any observation/complications.
- Applications of Private Institutes (New and Old both) for Center Creation be submitted through online portal before 9th January, 2026. (Application in hard form would not be accepted)
- Center Creation fee of Rs.80000/- shall be charged from institutions who are willing for creation of center in their institute under the cluster policy.
- Private Candidates are allowed to appear in 9th class Examination 2026 without submitting school leaving certificate with the condition of submitting attested copy of Form-B/CNIC (NADRA) or birth certificate from Secretary Union Council, along with admission form (hard copy and online) in due date.
- Candidate(s) of Wafaq-UI-Madaris who wants to take additional subjects must provide attested photocopy of IBCC Equivalency Certificate at the time of admission. Otherwise, his/her admission form would not be accepted.
- A candidate migrated from other Board for class 10th will have to appear in class 9th practical/Subject(s) exam if she/he has not taken Practical Exam in that Board.
- All those candidates who attempt for improvement of marks, shall not be considered as position holders or for any other type of awards/medal/scholarships in SSC Annual-I Examination 2026.
- Institutes shall submit online admission forms on the board online portal and a hard copy of the system generated admission/batch list duly signed by the head of institution within due date of the notification.
- A Regular/Private student of other Board seeking admission in the 10th class must provide proper migration certificate along with school leaving certificate and verified DMC of 9th class Examination.
- A candidate, passed with grace marks or in aggregate, appearing for improvement will have to appear in that paper for improvement passed with grace marks or in aggregate otherwise his improvement will not be considered.
- Regular/Private Roll No slips shall be available on web portal in **March, 2026**. Duplicate Roll No slips shall be available from One Window Service (OWS) of the Board for those who fail to receive roll number slips.
- All those candidates of 10th class who have passed 9th class in **SSC Annual-I Exam 2025** and did not appear in **SSC Annual-II Exam 2025**, can apply for improvement in **Annual-I exam 2026**. Regular candidates shall apply through school portal.
